TESTIMONY - Jesumene Pierre, a VSLA member and farmer, shares, "Plant With Purpose is a model of empowerment." Jesumene has seen great improvements on her farm yet the most encouraging transformation is her faith. She explains, "Plant With Purpose is the first institution to come to Fonds-Verrettes and teach us about God. They gave me a Creole Bible. Before, I couldn't understand the Bible readings in church because they were in French. Thanks to Plant With Purpose, I now read, understand, and practice the Word in my life."

TESTIMONY - As a member of the "Progressing" savings group, Mr. Cheo is improving his life. He shares, "This group has liberated us from slavery. We were forced to turn to 'loan sharks' who charged high interest. Now we are free and use our own savings. We own the interest rate!" To earn additional income Mr. Cheo started a small grocery store out of his home. A cement foundation has been poured next door-symbolizing the expansion of his business and financial freedom. In the Dominican Republic, 100 percent of partnering households are VSLA members (2014 Impact Evaluation).

TESTIMONY - Pasilida Tarimu's goal is to plant a forest on her property. Her steep hillside farm stood bare when she began partnering with Plant With Purpose in 2007. She plants 600 trees a year-some now stand 30 feet tall. Pasilida is combating deforestation and sees the local impact these trees are having in streams flowing year-round and birds returning to the area.

PERFORMANCE REVIEWS: Once a year, the Executive Committee meets with the Executive Director for his/her annual performance review and evaluation. In preparation for this review, the Executive Committee, with the participation of the Director of Finance & Administration, conducts evaluative research into comparative and equitable compensation of the Executive Director (including alignment with internal historical compensation trends) based upon others in a similar position and in relation to organization size and geographical location--while ensuring the organizational standard of equitable pay to not be in the highest percentile of comparable position pay. At such time, the Executive Committee reviews performance, offers suggestions on improvements, and negotiates salary adjustments based upon prepared research. Complete records are kept on the performance evaluation and the discussions at the review. There are no conflicts of interests among the Executive Committee and the Executive Director. The last time a performance evaluation was conducted for the Executive Director was September 2015. \*\*\*KEY EMPLOYEE PERFORMANCE REVIEWS: Similar is performed with key employees, where Quarterly Performance Reviews are conducted between the employee and the Executive Director; and an Annual Performance Evaluation, including compensation review, of each key employee is initially reviewed and discussed between the Executive Director and the Personnel Committee, and then conducted between the employee and the Executive Director. Compensation is determined based upon a number of factors, including but not limited to performance, value to the organization, and research of non-profit compensation surveys with regards to comparable position, job duties, organizational size, and geographical location. The last Annual Evaluation, including compensation review, of key employees was conducted July 2015. The last Quarterly Review of key employees was conducted April 2015. \*\*\*OTHER EMPLOYEE PERFORMANCE REVIEWS: Similarly, for non-key and non-executive employees, Performance Evaluations are conducted by the employee's immediate supervisor on a quarterly basis (including an Annual Performance Evaluation) and reviewed annually by the Personnel Committee. As with executive and key employees, compensation is determined based upon a number of factors, including but not limited to performance, value to the organization, and research of non-profit compensation surveys with regards to comparable position, job duties, organizational size, and geographical location. The last Annual Performance Evaluations were conducted July 2015, and Quarterly Reviews in April 2015. \*\*\*MISC: For all employees (executive, key, and others), if personnel issues occur throughout the year, the issue is discussed between any and all persons involved, the Executive Director, HR and/or the immediate supervisor, and either or both the HR Committee and the Executive Committee. Probationary or terminal decisions are always made with the consensus of the immediate supervisor (if applicable), the Executive Director, and either or both the HR Committee and Executive Committee.
